ORDER

The petitioner who was arrested on 29.04.2021 and remanded to judicial custody for the offences under Sections 4(1)(aaa) r/w 4 (1-A) of TNP Act and 4, 5 of Tamilnadu Sprit rules in Cr.No.661 of 2021 on the file of the respondent police, seeks bail.

2. The case of the prosecution is that the petitioner was found in illegal possession of 35 liters of Rectified Sprit. Hence, the complaint.

3. The learned counsel for the petitioner would submit that the petitioner is an innocent person and he has been falsely implicated in this case. He would further submit that he is ready to abide by any stringent condition that may be imposed by this Court.

4. The learned Government Advocate (Cr1. Side) on instructions submitted that the petitioner is a habitual offender and a proposal has been sent to the Government to detain the petitioner under the Goondas Act.

5. Considering the submissions made by the learned Government Advocate (Crl.Side), this is not a fit case for grant of bail. Therefore, this Criminal Original Petition is dismissed.
