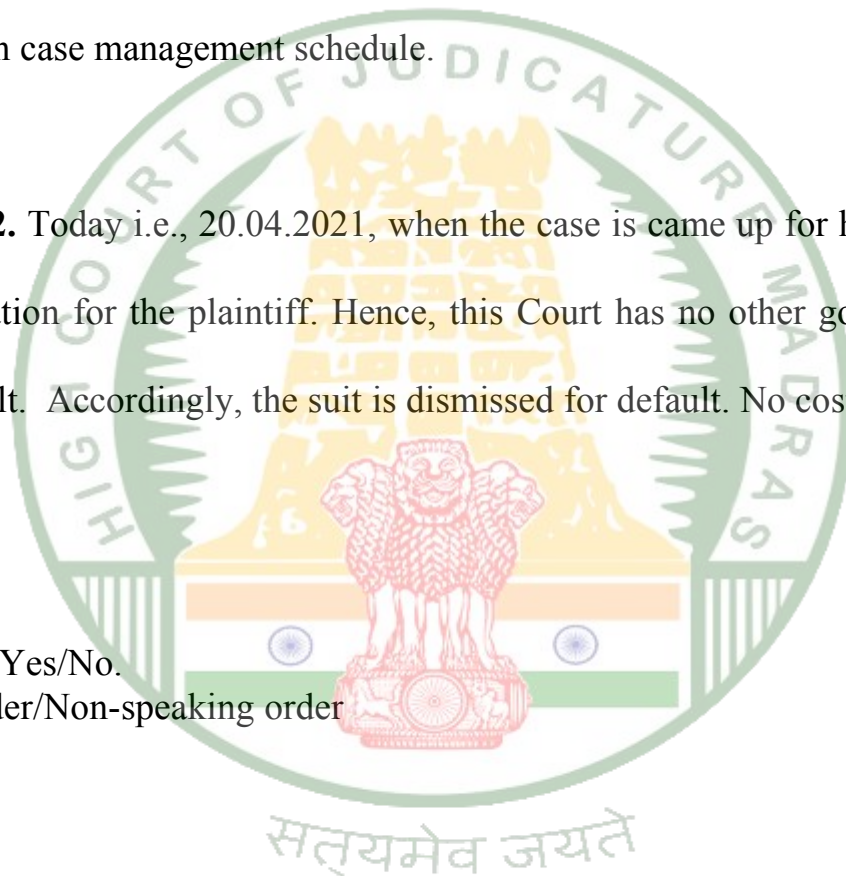
JUDGMENT

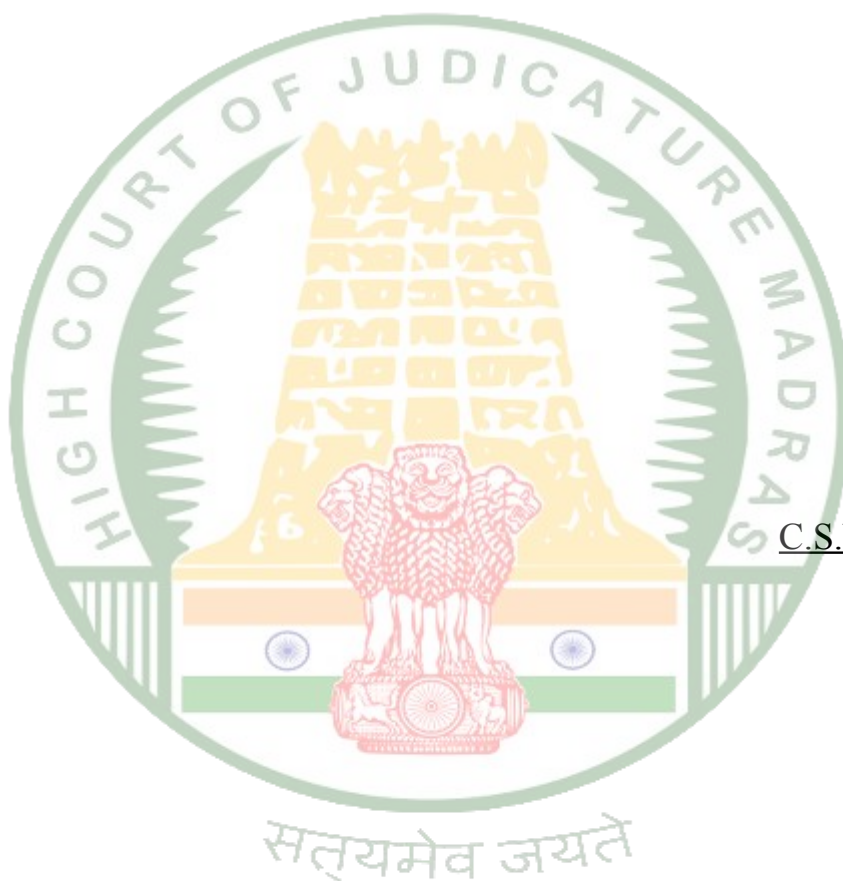
