This criminal miscellaneous petition has been filed seeking to grant suspension of sentence imposed on the petitioner by judgment and order

2. It is seen that there are many previous cases pending against the petitioner and one such case pending in P.R.C.No.94 of 2009 for the offences under Sections 307 and 392 IPC.

3. In such view of the matter, this is not a fit case to grant suspension of sentence and bail to the petitioner at this stage and hence, this criminal miscellaneous petition is dismissed for the present.

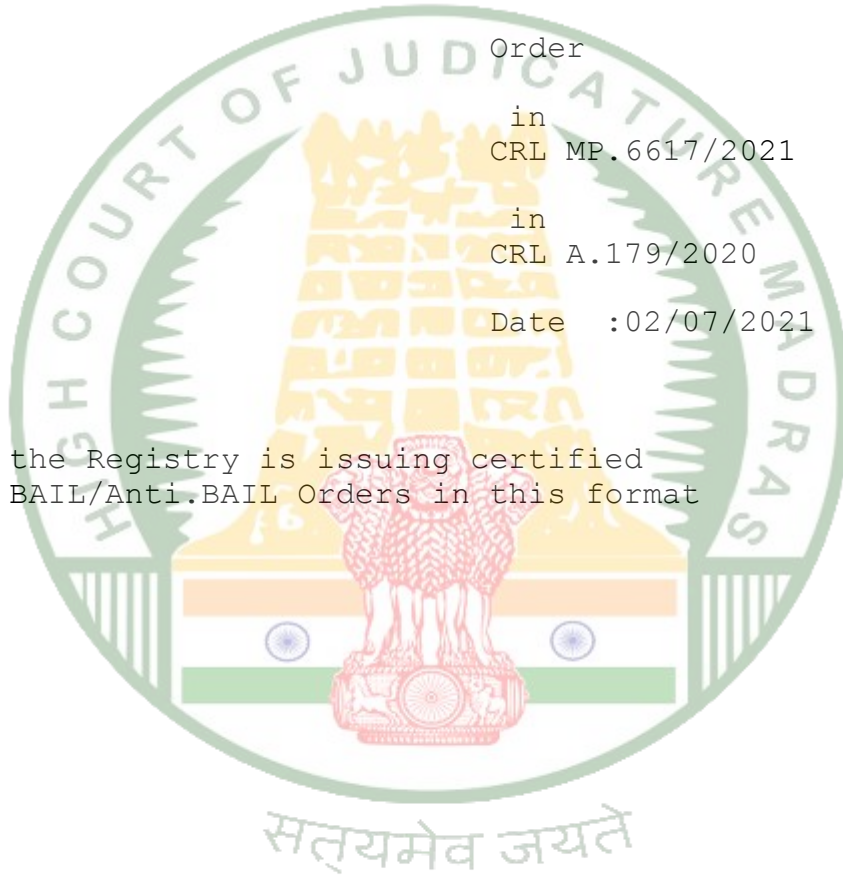
