This Criminal Original Petition has been filed to modify the condition imposed on the petitioner in Crl.M.P.No.2295 of 2021 dated 12.05.2021 on the file of the Vacation Judge (Criminal Side) at Tiruvallur .

The learned counsel for the petitioner would submit that, as per the condition imposed by the Court below in Crl.M.P.No.2295 of 2021 dated 12.05.2021, the petitioner had appeared before the Inspector of Police, Vellore South Police Station regularly and hence, he seeks for modification of the condition imposed.
