3.Learned Government Advocate (Crl.Side) submits that the petitioner has been complying with the conditions imposed by this Court.

4.In the above circumstances, this petition is allowed relaxing the condition by permitting the petitioner to appear before the respondent police as and when required for interrogation. Except the above modification, all other conditions imposed by this Court in its



order dated 09.03.2021 stand unaltered.
