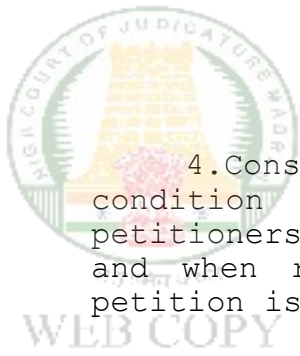

2.Heard the learned Counsel appearing for the petitioners.

3.The learned Government Advocate (Crl.Side) submitted that the petitioners are complying with the condition regularly.



4. Considering the facts and circumstances of the case, the condition already imposed by this Court is relaxed and the petitioners are directed to appear before the respondent police, as and when required for interrogation on receipt of summons. This petition is ordered.
