4. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioners could be acceded to.

Accordingly, the condition insofar as appearance as imposed by order dated 31.03.2021 alone stands modified that till filing of the charge sheet, the petitioners are directed to appear before the respondent police fortnightly ie., on 1st and 15th of every month at 10.30 a.m, and thereafter, the petitioners are directed to appear before the concerned court on each and every hearing dates at 10.30 a.m, until further orders. All other conditions remain unaltered.
