No.24281/E1/5/2019 insofar as it relates to vacancies arisen in Bio-Chemistry Specialty and quash the same as illegal, arbitrary and devoid of merits in respect of petitioner for not selecting in Promotion List and consequently direct the 3rd respondent to hold fresh promotion counselling for the year 2018-2019 after including the name of the petitioner in the promotion Panel List under Bio-Chemistry Specialty.
