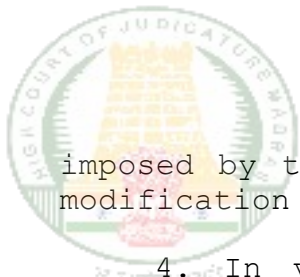

This Court while granting anticipatory bail to the petitioner in Crl.OP.No.9034 of 2021 dated 12.05.2021 has ordered to deposit a sum of Rs.2,00,000/- (Rupees Two Lakhs Only) to the credit of Cr.No.222 of 2020 before the learned District Munsif-cum-Judicial Magistrate, Ranipet.

3.The learned Government Advocate (Crl. Side) for the respondent submits that the petitioner had not complied with the condition



imposed by this court till now and hence, he vehemently opposed for modification of condition.

4. In view of no representation for the petitioner and non-compliance of the order dated 12.05.2021 in Crl.OP.No.9031 of 2021, this petition is liable to be dismissed and hence, this Petition is dismissed.
