ORDER

[Order of the Court was made by S.SRIMATHY, J]

The petitioner is wife of the detenu viz., Subash s/o.Muralidharan, aged 28 years. The detenu has been detained by the second respondent by his order in Cr.M.P.No.08/G/2021/E1 dated 31.05.2021, holding him to be a "Goonda", as contemplated under Section 2(f) of Tamil Nadu Act 14 of 1982. The said order is under challenge in this Habeas Corpus Petition.

Learned Government Advocate [Crl.side] would submit that the detention order passed against the detenu in Cr.M.P.No.08/G/2021/E1 dated 31.05.2021, on the file of the second respondent is revoked vide G.O.Rt.No.3314, Home, Prohibition and Excise (XII) Department, dated 26.07.2021 and produced a copy of the said order.

In view of the above, this petition is closed as it has become infructuous.
