which the appeal is filed.

representing the case being present make a statement that the
appellant is not prosecuting the appeal, whereas they have
decided to withdraw the appeal, and acknowledging the same in
writing, endorsement was made in the appeal memorandum.
Recorded. No representation for the respondents and
representation could be dispensed with since by withdrawing by

the appeal no prejudice could be caused to the respondents and in the absence of other side, endorsed could be accepted, case can be disposed of, if at all the original award shall stand for which there cannot be any grievance for anybody.

3. Under the above said circumstances appeal is dismissed as withdrawn and settled, as per the endorsement. Consequently connected Miscellaneous Petition is closed.
