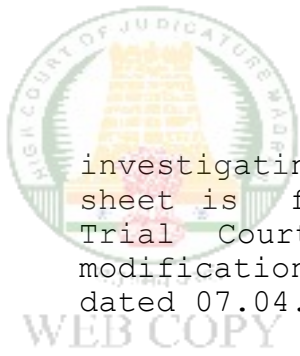

The present petition has been filed to relax the condition imposed on the petitioner in clause (b) of the order dated 07.04.2021 passed by this Court in Crl.O.P.No.3827 of 2021.

2.This Court, vide order dated 07.04.2021, directed the petitioner shall report before the respondent policy daily at 10.30 a.m., until further orders.

3.Learned Government Advocate (Crl.Side) submits that the petitioner has been complying with the conditions imposed by this Court.

4.In the above circumstances, this petition is allowed relaxing the condition by permitting the petitioner to appear before the



investigating officer on every Monday at 10.30 a.m., till the charge sheet is filed, after the petitioner shall appear before the Trial Court on all hearing dates without fail. Except the above modification, all other conditions imposed by this Court in its order dated 07.04.2021 stand unaltered.
