ORDER

The petitioner is now at liberty to file a fresh application before the Revenue Divisional Officer, Tiruvarur, which he undertakes to file within one month from the date of receipt of a copy of this order, wherein the Revenue Divisional Officer, Tiruvarur, is required to dispose of the matter within a period of four months subject to any notification or inconvenience that may arise, due to the notification of the Assembly Election in the State.
