Petition filed under Section 439 of Cr.P.C., seeking to enlarge the petitioner/ accused on bail in the aforementioned Crime No.64 of 2021, on the file of the Inspector of Police, Pennalurpet Police Station, Thiruvallur District.

ORDER

The petitioner who was arrested and remanded to judicial custody on 10.04.2021 for the offence under Section 174(3) of Cr.P.C. and subsequently converted into Section 306 of IPC in Cr.No.64 of 2021 on the file of the respondent police, seeks bail.

2.It is the case of the prosecution that the petitioner performed love marriage and was blessed with a female child and thereafter, there was no compatibility inbetween the petitioner and his wife. The petitioner is an alcoholic and is alleged to have quarrel with his wife frequently and used to harass her, due to which, she committed suicide.

3.The learned counsel appearing for the petitioner submitted that the petitioner has not committed any offence as alleged by the prosecution and that he has been falsely implicated in this case. He further submitted that the petitioner was not aware of the suicide committed by the deceased.

4.The learned Government Advocate (Crl. Side) submitted that RDO enquiry is pending and that the investigation has not yet been completed.

5.Considering the period of incarceration undergone by the petitioner, I am inclined to grant bail to the petitioner.

6.Accordingly, the petitioner is ordered to be released on bail on the following conditions:

(a) the petitioner shall execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand Only) before the Superintendent of Central Prison, Puzhal, Chennai, in which the petitioner is confined and on such execution the petitioner shall be released from prison;

(b) within a period of four weeks after the release, the petitioner shall execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand Only) with two sureties, each for a like sum to the satisfaction of the learned Judicial Magistrate, Uthukottai, Thiruvallur District;

(c) in case of any difficulty in executing the said bond along with the sureties before the concerned Magistrate within the time stipulated above, the petitioner is permitted to file appropriate petition within a period of four weeks therefrom before the concerned Magistrate for extension of time for executing the bond along with sureties and if any such application is filed, the concerned Magistrate shall decide on the grant of extension of time for accepting the bond and sureties in accordance with law. Failing filing of any such application within the time prescribed above, the bail granted by this Court would stand automatically vacated;

(d)the sureties shall affix their photographs and left thumb impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity;

(e)the petitioner shall report before the respondent police, daily at 10.30 a.m. until further orders;

(f)the petitioner shall not tamper with evidence or witness either during investigation or trial;

(g)the petitioner shall not abscond either during investigation or trial;

(h)on breach of any of the aforesaid conditions, the learned Magistrate/ Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji Vs. State of Kerala [(2005) AIR SCW 5560]**; and;

(i)if the accused thereafter absconds, a fresh FIR can be registered under Section 229-A IPC.
