The present petition has been filed to relax the condition imposed on the petitioners in clause (d) of the order dated 24.08.2020 passed by this Court in Crl.O.P.No.12852 of 2020.

2.This Court, vide order dated 24.08.2020, directed the petitioners to appear before the respondent police daily at 10.30 a.m., for a period of two weeks and thereafter, on every Monday at 10.30 a.m., until further orders.

3.Learned Government Advocate (Crl.Side) submits that the petitioners have been complying with the conditions imposed by this Court.



4. In the above circumstances, this petition is allowed relaxing the condition by permitting the petitioners to appear before the respondent police once in a month i.e., on the first working day of every month at 10.30 a.m., until further orders. Except the above modification, all other conditions imposed by this Court in its order dated 24.08.2020 stand unaltered.
