2. This Court, vide order dated 26.03.2021, directed the petitioner to report before the respondent police daily at 10.30 a.m., until further orders.

3. Learned Government Advocate (Crl.Side) submits that the petitioner has been complying with the conditions imposed by this Court.

In the above circumstances, this petition is allowed relaxing the condition by permitting the petitioner to appear before the respondent police as and when required for interrogation on receipt of summons. Except the above modification condition, all other conditions imposed by this Court in its order dated 26.03.2021 stand unaltered.
