The present petition has been filed to modify the condition imposed by this Court in the order dated 27.04.2021 made in Crl.OP.No.7910 of 2021 to deposit a sum of Rs.50,000/- (Rupees Fifty Thousand Only) each, through demand draft in favour of the Dean, Rajiv Gandhi Government Hospital, Chennai to enable the Dean to use the aforesaid amount for the purpose of treating Covid-19 patients,

2. This Court vide order dated 27.04.2021 in Crl.OP.No.7910 of 2021 in Crime No.98 of 2021, while granting anticipatory bail to the petitioners, imposed one of the aforesaid conditions.

3. The learned counsel for the petitioner has submitted that the condition imposed that the petitioners shall deposit a sum of Rs.50,000/- each has to be modified to the effect that the petitioners shall jointly deposit a sum of Rs.50,000/- .

4. Learned Government Advocate (Crl.Side) submits that he has no objection for granting the said modification.

5. In view of the above, the condition is modified to the effect that the the petitioners shall jointly deposit a sum of Rs. 50,000/- (Rupees Fifty Thousand only) through demand draft in favour of the Dean, Rajiv Gandhi Government Hospital, Chennai. Apart from the aforesaid modification, the order passed by this court in Crl.OP.No.7910 of 2021 dated 27.04.2021 shall stand unaltered in all other aspects.
