O R D E R

This petition has been filed seeking a direction to respondents to produce the petitioner's daughter, namely, S.Yuvasri D/o.K.Srinivasan, aged about 15 years, before this Court and hand over her to the petitioner.

2. On 29.06.2021, we passed the following order:

'It is the case of the petitioner that her daughter S.Yuvasri, daughter of K.Srinivasan, aged about 15 years, went missing from 01.06.2021 and that the police are not taking effective steps to secure her.

2. On instructions, the learned Government Advocate (Crl.Side) submitted that on a complaint given by the petitioner, a case in Thirumullaivoyal Police Station Crime No.419 of 2021 for 'girl missing' was registered on 04.06.2021 and investigation is in progress.

3. In such view of the matter, this Court issues a direction to the Assistant Commissioner of Police, Ambattur, to monitor the investigation in Thirumullaivoyal Police Station Crime No.419 of 2021 and keep the petitioner informed of the developments, if any. As and when the detinue S.Yuvasri, daughter of K.Srinivasan, aged about 15 years, is secured, she shall be produced before the Judicial Magistrate Court, Ambattur, under intimation to the petitioner. On such production, the learned Magistrate shall pass appropriate orders with regard to the custody in accordance with law.

Post the matter on 27.07.2021.'

3. Today, when the matter is taken up for hearing, learned Government Advocate [Crl.side] submits that the detinue S.Yuvasri was secured by the police on 14.07.2021 and was produced before the learned Judicial Magistrate, Ambattur and she was handed over to the petitioner.

Recording the same, this Habeas Corpus Petition stands closed.
