4. In the light of the aforementioned memo and reiteration of the same, captioned OP is dismissed as withdrawn. There shall be no order as to costs.

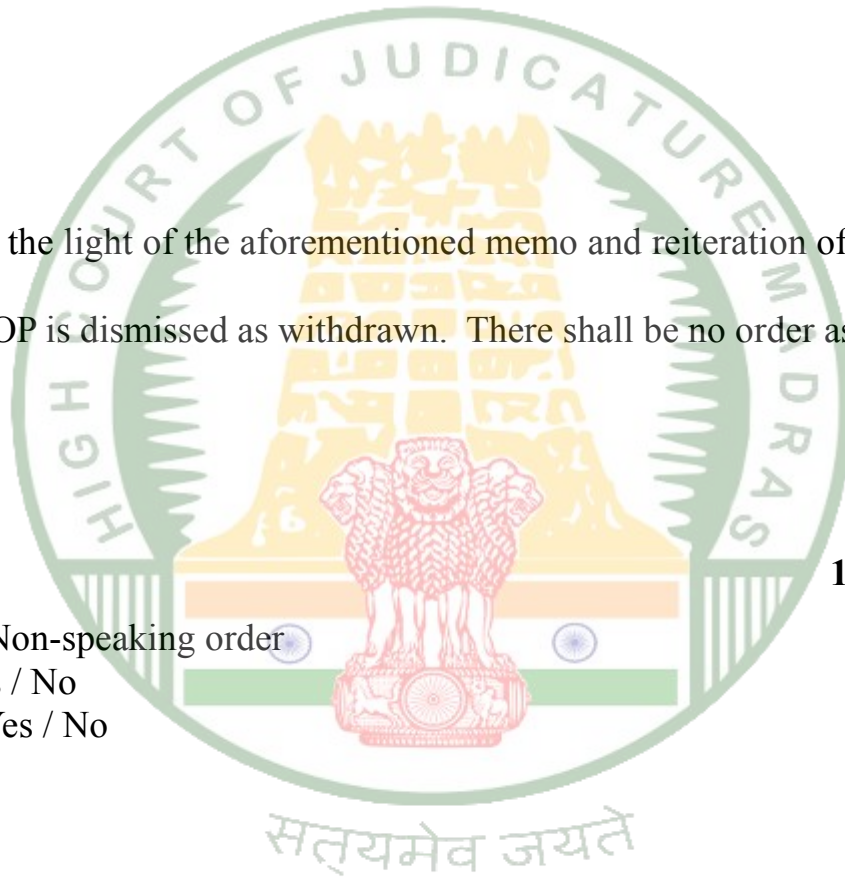
