2. This Court, vide order dated 29.04.2021 directed the petitioner to report before the respondent police once in a week, i.e., on every Monday at 10.30 a.m., until further orders.

3. Learned Government Advocate (Crl.Side) submits that the petitioner has been complying with the conditions imposed by this Court.

In the above circumstances, this petition is allowed by modifying the condition that the petitioner is directed to appear before the respondent police on every Monday at 10.30 a.m, until further orders. Except the above modification condition, all other conditions imposed by this Court in its order dated 22.02.2021 in Crl.OP.No.2508 of 2021 stand unaltered.
