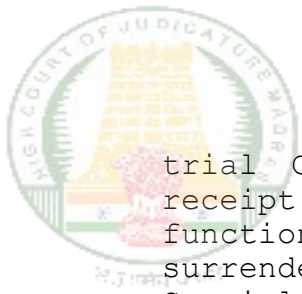

ORDER

This Criminal Original Petition has been filed to direct the learned Principal District Judge, Cuddalore cum Special Judge for SC & ST (P.A) Act, Cuddalore to consider the bail application of the petitioners on the same day in the event of their surrender in connection with Crime No.1 of 2021 on the file of the respondent police.

2.In view of the amendments made in the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989, this Court is of the view that the usual directions that were issued by this Court cannot be issued routinely in all cases. Therefore, the petitioners are directed to surrender before the



trial Court within a period of two weeks from the date of receipt of a copy of this order or after commencement of normal functioning of the Court, which ever is later and on such surrender, the learned Principal District Judge, Cuddalore cum Special Judge for SC & ST (P.A) Act, Cuddalore shall deal with the matter on the same day on merits and in accordance with law, after issuing notice to the victims under Section 15-A (3) of the SC/ST Act.

3.This Criminal Original Petition is disposed of with the above directions.
