2. This Court, vide order dated 28.04.2021 directed the petitioner to report before the respondent police once in a week, ie., on every Monday at 10.30 a.m., until further orders.

3. Learned Government Advocate (Crl.Side) submits that the petitioner has been complying with the conditions imposed by this Court.

4. In the above circumstances, this petition is allowed by modifying the condition that till filing of the charge sheet, the petitioner is directed to appear before the respondent police on the 1st working day of every English Calendar month at 10.30 a.m, and thereafter, the petitioner is directed to appear before the concerned court on each and every hearing dates at 10.30 a.m, until further orders. Except the above modification condition, all other conditions imposed by this Court in its order dated 10.03.2021 in Crl.OP.No.3018 of 2021 stand unaltered.
