The learned Additional Public Prosecutor reports that the order of detention passed against the detenu has been revoked by the Government by its order in G.O.Rt.No.3637, Home, Prohibition and Excise (IX) Department, dated 04.09.2020 and he has also produced a copy of the Government Order.
