Section 3 and 4 of Tamil Nadu Prohibition of Charging Exorbitant Interest Act, 2003, in Crime No.330 of 2021, while granting anticipatory bail.

2.Heard the learned Counsel appearing for the petitioner.

3.The learned Government Advocate submitted that the petitioner is complying with the condition regularly.

4.Considering the facts and circumstances of the case, the condition already imposed on the petitioner is relaxed and the petitioner shall appear before the respondent police, as and when required for interrogation on receipt of summons.
