Thereafter, the Police took the respondent to his residence at Anna Nagar, Madurai and the respondent produced one Samsung Mobile phone in presence of witnesses. The Samsung mobile phone was seized by preparing Mahazar and Form-95.



2. Following the direction of this Court, the respondent was treated properly and he was handed back to the Jail authorities. Hence, no order is required to be passed in this matter.
