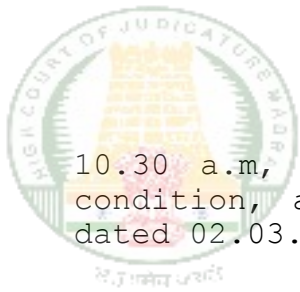
(The case has been heard through video conference)
