ORDER

This Criminal Original Petition has been filed seeking a direction, to direct the learned Principal District and Sessions Court, Villupuram District to consider the bail application of the petitioners concerned in Crime No.402 of 2021, on the file of the Inspector of Police, Thirunavalur Police Station, Kallakurichi District on his surrender on the same day.

2.In view of the amendments made in the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989, this Court is of the view that the usual directions that were issued by this Court cannot be issued routinely in all cases. Therefore, the petitioners are directed to

surrender before the trial Court within a period of two weeks from the date of receipt of a copy of this order and on such surrender, the learned Principal District and Sessions Court (Special Court for SC/ST Act), Villupuram District, for SC/ST Act cases under SC & ST [Prevention of Atrocities] Act, 1989, shall deal with the matter on the same day on merits and in accordance with law, after issuing notice to the victims under Section 15 - A(3) of the SC/ST Act.

3.This Criminal Original Petition is disposed of with the above directions.
