2.The learned counsel appearing for the petitioner submitted that the petitioner is very poor and that he is not in a position to deposit the conditional amount and prayed this Court to modify the amount.

3.Heard the submissions made by the learned Government Advocate (Crl. Side).



4. Considering the submission made by the learned counsel appearing for the petitioner, the amount imposed on the petitioner in the order dated 22.06.2021 made in Crl.O.P.No.10732 of 2021 is reduced from Rs.25,000/- to Rs.10,000/-. The conditional amount is accordingly modified.
