3. Learned Government Advocate (Crl.Side) appearing for the respondent, on instruction, submits that the petitioner has been complying with the conditions without fail.

4. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.

Accordingly, the condition insofar as appearance as imposed by order dated 30.11.2020 alone stands modified that till filing of the charge sheet, the petitioner is directed to appear before the respondent police on every Monday at 10.30 a.m, and thereafter, the petitioner is directed to appear before the concerned court on each and every hearing dates at 10.30 a.m, until further orders. All other conditions remain unaltered.
