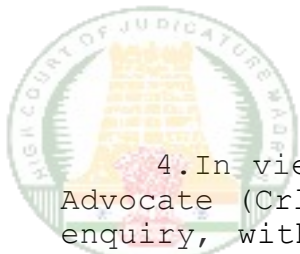
PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioners, who apprehend arrest at the hands of the respondent Police for the offence punishable under Sections 498(A) of IPC R/w Section 4 of Dowry Prohibition Act 1961, in Crime No.(Not known), seek anticipatory bail.

3. When the matter is taken up for hearing, the learned Government Advocate (Crl.Side) appearing for the respondent Police submitted that petition enquiry is pending against the petitioners in C.S.R.No.144 of 2021.
