Petition filed under Article 226 of the Constitution of India, praying to issue a Writ of Habeas Corpus, calling for the records relating to the detention order passed by the second respondent pertaining to the order made in BCDFGISSSV No.291/2020 dated 15.08.2020 in detain the detenu under 2(b) of Tamilnadu Act 14 of 1982, as a Goonda and quash the same and direct the respondents to produce the detenu Ramesh @ Rameshkumar, son of Kandhan, aged about 23 years, who is detained at Central Prison, Puzhal, Chennai, before this Court and set him at liberty.

O R D E R

[Order of the Court was made by R.PONGIAPPAN, J.]

The petitioner is the mother of Ramesh @ Rameshkumar, son of Kandan, aged about 23 years, who is the detenu. The detenu has been detained by the second respondent by his order in BCDFGISSSV No.291/2020 dated 15.08.2020, holding him to be a "Goonda", as contemplated under Section 2(f) of Tamil Nadu Act 14 of 1982. The said order is under challenge in this Habeas Corpus Petition.

2. We have heard the learned counsel appearing for the petitioner and the learned Additional Public Prosecutor appearing for the respondents and we have also perused the records carefully.

3. Though several grounds have been raised, learned counsel for the petitioner mainly focused his arguments on the ground that the ground case remand extension order has not been enclosed, which caused great prejudice to the detenu and he has been prevented from making an effective representation for consideration of the authorities concerned. Therefore, the impugned order of detention is vitiated in law.

4. A perusal of the booklet would go to show that the remand extension order of the ground case was not enclosed in the booklet furnished to the detenu. Therefore, non-furnishing of the above materials would obviously deprive of his opportunity to make effective representation and hence, we are of the opinion that the detention order is liable to be quashed on this ground.

5. In the result, the Habeas Corpus Petition is allowed and the order of detention in BCDFGISSSV No.291/2020 dated 15.08.2020, passed by the second respondent is set aside. The detenu, namely, Ramesh @ Rameshkumar, son of Kandan, aged about 23 years, is directed to be released forthwith unless his detention is required in connection with any other case.
