2. Learned Government Advocate (Crl. side) appearing for the respondent, on instruction, submits that the petitioner has been complying with the conditions without fail.

3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.

4. Accordingly, the condition insofar as appearance as imposed by order dated 07.06.2021 stands modified and the petitioner shall appear before respondent police on every Monday and Fridays at 10.30 a.m. till filing of the charge sheet and thereafter shall appear before the trial Court on each and every hearing date. All other



conditions remain unaltered.
