2. In purported compliance of the order passed by this Court, the learned Government Counsel appearing for the respondent furnished the proceedings dated 21.08.2018 in Ref.No.43268/E6/1/2018-1 to 4. It is also stated that the consequential monetary benefits have also been given to the petitioner.

3. The learned counsel for the contempt petitioner submitted that the seniority must be CML 4370 as against 4683. However, we are afraid that it was not the subject matter of the writ appeal.
