In the above circumstances, this petition is allowed relaxing the condition by permitting the petitioner to appear before the respondent police as and when required for interrogation on receipt of summons. Except the above modification condition, all other conditions imposed by this Court in its order dated 09.06.2021 stand unaltered.
