Order : This petition coming on for orders upon perusing the petition and the filed in support thereof and upon hearing the arguments of M/S M.AYYADURAI, Advocate for the petitioner and of M/S. C.E.PRATAP, Govt. Advocate (Crl. Side) on behalf of the Respondents the court made the following order:-

Vide order dated 19.02.2020, this Court had granted bail on certain conditions and in one of the condition, the petitioner is directed to appear before the respondent police daily at 10.30 am and 5.30 pm for a period of one month and thereafter daily at 10.30 am until further orders.

2. The present petition has been filed seeking modification of the said condition.

3. Learned Addl. Public Prosecutor appearing for the respondents, on instruction, submits that the petitioner has been complying with the conditions without fail.



3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.

4. Accordingly, the condition insofar as appearance as imposed by order dated 19.02.2020 alone stands modified and the petitioner shall appear before the respondent police, every Monday at 10.30 a.m. till the investigation is completed and charge sheet is filed and thereafter, shall appear before the concerned trial Court on each and every date of hearing.
