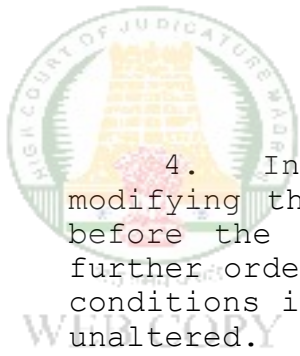

3. Learned Government Advocate (Crl.Side) submits that the petitioners have been complying with the conditions imposed by this Court.
