The present petition has been filed to modify the condition imposed on the petitioner in clause(a) of the order dated 26.03.2021 passed by this Court in Crl.M.P.No.3109 of 2021 in Crl.O.P.No.19942 of 2020.

2. This Court, vide order dated 26.03.2021, directed the petitioner to appear before the respondent police on every Monday at 10.30 a.m., until further orders.

3. The learned counsel for the petitioner submitted that the petitioner is complying with the conditions regularly.

4. The learned Government Advocate (Crl.Side) submits that the petitioner is not complying with the conditions imposed by this Court.



6. Considering the facts the petitioner has not complied with the conditions imposed by this Court in Crl.M.P.No.3109 of 2021 in Crl.O.P.No.19942 of 2020., this Court is not inclined to relax the conditions imposed on the petitioner.
