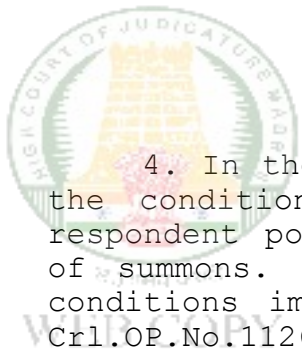

The present petition has been filed to relax the condition imposed on the petitioner in Para 4 of the order dated 23.12.2020 passed by this Court in Crl.M.P.No.8602 of 2020 in Crl.O.P.No.11266 of 2020.

2. This Court, vide order dated 23.12.2020 directed the petitioner to report before the respondent police on first of every month, until further orders.

3. Learned Government Advocate (Crl.Side) submits that the petitioner has been complying with the conditions imposed by this Court.

In the above circumstances, this petition is allowed relaxing the condition by permitting the petitioner to appear before the respondent police as and when required for interrogation on receipt of summons.
