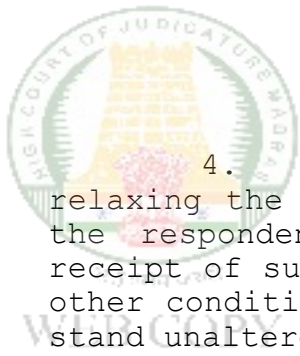

3. Learned Government Advocate (Crl.Side) submits that the petitioner has been complying with the conditions imposed by this Court.

Except the above modification condition, all other conditions imposed by this Court in its order dated 15.06.2020 stand unaltered.
