2. This Court, vide order dated 09.12.2020 directed the petitioner to report before the respondent daily at 10.30 a.m., for a period of two weeks and thereafter, every Monday at 10.30 a.m., until further orders.

3. Learned Government Advocate (Crl.Side) submits that the petitioner has been complying with the conditions imposed by this Court regularly.

In the above circumstances, this petition is allowed by modifying the condition that till filing of the charge sheet, the petitioner is directed to appear before the respondent police fortnightly ie., on 1st and 15th of every month at 10.30 a.m, until further orders. Except the above modification condition, all other conditions imposed by this Court in its order dated 09.12.2020 stand unaltered.
