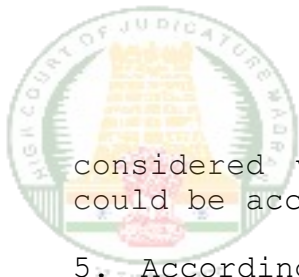
Order : These petitions coming on for orders upon perusing the petitions and the filed in support thereof and upon hearing the arguments of M/S.R.C.PAUL KANAGARAJ, Advocate (in both petitions) and of MR.C.E.PRATAP, Govt. Advocate (Crl. Side)(in both petitions) on behalf of the Respondent the court made the following order:-

Vide order dated 16.06.2021 this Court had granted anticipatory bail on certain and in one of the condition, the petitioners were directed to appear before the respondent Police daily at 10.30 a.m until further orders.

2. These petitions have been filed seeking modification of the said condition.

3. Learned Addl. Public Prosecutor appearing for the respondents, on instruction, submits that the petitioners have been complying with the conditions without fail.

4. In view of the above submission, this Court is of the



considered view that the prayer as sought for by the petitioners could be acceded to.

5. Accordingly, the condition insofar as appearance as imposed by order dated petitioners shall appear before the respondent police, once in 15 days i.e., on every first and third Monday at 10.30 a.m. till the investigation is completed and charge sheet is filed and thereafter, shall appear before the concerned trial Court on each and every date of hearing. All other conditions remain unaltered.
