Vide order dated 16.06.2021 this Court had granted anticipatory bail on certain and one of the condition is that the petitioner was directed to appear before the respondent Police daily at 10.30 a.m until further orders.

2. The present petition has been filed seeking modification of the said condition.



3. Learned Addl. Public Prosecutor appearing for the respondents, on instruction, submits that the petitioner has been complying with the conditions without fail.

3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.

4. Accordingly, the condition insofar as appearance as imposed by order dated 16.06.2021 alone stands modified and the petitioner shall appear before the respondent Police once in 15 days till filing Charge Sheet. All other conditions remain unaltered.
