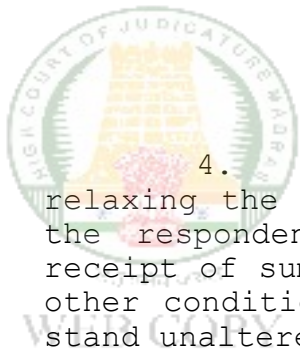

The present petition has been filed to relax the condition imposed on the petitioners in Clause 5(e) of the order dated 25.06.2021 passed by this Court in Crl.O.P.No.10949 of 2021.

2. This Court, vide order dated 25.06.2021, directed the petitioners to report before the respondent police daily at 10.30 a.m., until further orders.

3. Learned Government Advocate (Crl.Side) submits that the petitioners has been complying with the conditions imposed by this Court.

In the above circumstances, this petition is allowed relaxing the condition by permitting the petitioner to appear before the respondent police as and when required for interrogation on receipt of summons. Except the above modification condition, all other conditions imposed by this Court in its order dated 25.06.2021 stand unaltered.
