Considering the said submission, the condition imposed on the petitioner is modified to the effect that the petitioner is directed to deposit a sum of Rs.10,000/- as non-refundable deposit to the Registered Advocate Clerk Association, Arakkonam and two weeks time is granted to the petitioner to surrender and execute the sureties as ordered by this Court.
