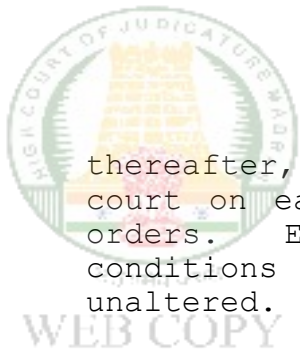

The present petition has been filed to relax the condition imposed on the petitioner in Clause 5(c) of the order dated 31.03.2021 passed by this Court in Crl.O.P.No.4708 of 2021.

2. This Court, vide order dated 31.03.2021, directed the petitioner to report before the respondent police daily at 10.30 a.m, until further orders.

3. Learned Government Advocate (Crl.Side) submits that the petitioner has been complying with the conditions imposed by this Court regularly.

4. In the above circumstances, this petition is allowed by modifying the condition that till filing of the charge sheet, the petitioner is directed to appear before the respondent police fortnightly i.e., on 1st and 15th of every month at 10.30 a.m, and



thereafter, the petitioner is directed to appear before the concerned court on each and every hearing dates at 10.30 a.m, until further orders. Except the above modification condition, all other conditions imposed by this Court in its order dated 31.03.2021 stand unaltered.
