2. Being satisfied with the reasons shown in the affidavit filed in support of the petition, the prayer sought for by the petitioner deserves to be considered favourably.



3. Accordingly, time is extended by a further period of two weeks from the date of receipt of a copy of this order for the petitioner to surrender before the concerned court and execute the bonds with two sureties. All other conditions remain unaltered.
