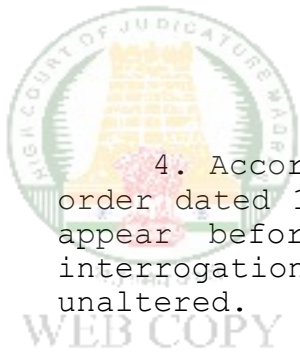

Vide Order dated 17.06.2021 in Crl.OP.No.10408 of 2021, this Court had enlarged the petitioner on bail on certain conditions. This petition has been filed by the petitioner seeking relaxation of the conditions.

2. Learned Government Advocate (Crl.Side) appearing for the respondents, on instruction, submits that the petitioner has been complying with the conditions without fail.

3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.
