2. The learned Additional Public Prosecutor submitted that the order of detention passed against the detenu has been revoked by the Government by its order in G.O.Rt.No.3958, Home, Prohibition and Excise (XIV) Department, dated 31.08.2021 and he has also produced a copy of the Government Order.
