The learned counsel for the petitioner submitted that the petitioner is complying with the conditional order of this Court till date without any default and is reporting before the respondent police on every Monday at 10.30 a.m. He further submitted that after lifting of lockdown and from commencement of regular function of court below, the petitioner has to report before the trial court daily at 10.30 a.m. However, it is very difficult for the petitioner



to comply with the condition. Hence, he seeks for modification of the said condition.
