Prayer: Writ appeal filed under Clause 15 of the Letters Patent against the order dated 13.04.2016 made in W.P.No.26991/2014 by a learned Single Judge.

Prayer in W.P.No.26991 of 2014:

Petition filed under Article 226 of the Constitution of India praying for the issuance of a Writ of Mandamus to the respondents (i) to give police protection to the petitioner who temporarily resides in Chennai (ii) to direct the respondents 1 and 2 to initiate departmental as well as criminal proceedings against the concerned police officials in terms of the judgment in Arumugam Servai's case reported in 2011(6) SCC 405 (iii) to handover the investigation to the death of Vimala D/o.Veeranan, Poothipuram Camp, Usilampatti Taluk, Madurai District to the CBI forthwith, and (iv) to direct the 1st respondent to pay a compensation of Rs.10 lakhs to the petitioner towards the death of Vimala.
